Policies of Qualification and Eligibility are the same for all three Nevada REALTORS PACs

100.2—Trustee and Officer Eligibility

The Trustees and Officers must be a Nevada REALTORS® member.

The Trustees and Officers shall be registered voters in Nevada.

The Trustees shall have prior service on one or more of the following committees: Local Political Affairs Committee, NV RPAC, APPR PAC, IMC, NVR’s Legislative Committee, NAR’s Issues Mobilization Committee, NAR’s Political Communications Committee, and RPAC.

Notwithstanding the above, the following members shall not qualify to be a Trustee or Officer of NV RPAC:

1. An individual member or the sole proprietor of a firm providing goods and services under contract to the federal government, including the leasing or selling of land or other real property, or interests in real property, during both the negotiation phase and the term of the contract, unless the relationship is fully disclosed, and then a decision will be made on a case by case basis.
2. A minor under the age of 18.
3. A foreign national. A foreign national is a person who is not a U.S. citizen or a national of the United States (as defined by U.S. Citizenship and Immigration Services rules) and who is not lawfully admitted for permanent residence.
4. The current NVR President.
5. Any person holding a Governor appointed position.

100.5—Trustee Authority and Duties

The Board of Trustees shall operate the affairs and funds of NV RPAC [RIPAC/RCPAC] within its guidelines established by the NVR Board of Directors, NAR and law, and shall establish and carry out all policies and activities of the Committee. The Trustees shall not receive reimbursement for any monies expended on behalf of a candidate for public office’s campaign.

The Trustees must make the commitment to carry out their assigned tasks, duties and responsibilities in accordance with the “Agreement To Serve” form. The Trustees should be a participant in the PAC, the suggested minimum annual contribution level is Sterling R.

The Trustees should encourage PAC participation by the leadership and general membership of NVR. Trustees are expected to contribute by a date established by NVR to achieve the highest state and national recognition in a given year.

When accepting the appointment for the positions of Trustee of NV RPAC [RIPAC or RCPAC], the appointee shall sign an Agreement To Serve form.
